

'above' Member Referral Rewards 2023
Terms & Conditions

1. The promotion period is from 6 October 2023 to 30 November 2023 (both dates inclusive) (the “**Promotion Period**”).
2. Only **above** members (excluding Pre-Member) are eligible to participate in the promotion.
3. Referrer is entitled to the Referrer reward(s) upon successfully referring a new **above** member during the Promotion Period by sharing their unique referral code, which is then used by the new member to register and upgrade to designated **above** membership tier during the Promotion Period.
4. Referee is entitled to the Referee rewards upon successful registering an **above** membership with a valid referral code and upgrading to designated **above** membership tier during the Promotion Period. Each referee will only be entitled to ONE (1) Referee reward according to the highest **above** membership tier after counting the eligible spending during the Promotion Period.
