Starstreet Precinct Pawsome Adventure Terms and Conditions

For the safety of all participants and staff, every participant must meet the following "Rules and Regulations" in order to participate in the event. If at any time during the event, any participant is assessed by staff as not being able to fulfil the following criteria, they will be asked to leave the venue and they must immediately comply with such directions.

- 1. The promotion period of Starstreet Precinct Pawsome Adventure Installation and Market ("event") is from 2 to 24 September 2023.
- 2. Pet(s) should not be left unattended under any circumstances. Participants should pay attention to the safety of themselves and their pets, and keep their pets under control effectively, in order not to cause any loss of pets, nuisance or danger to other people and pets.
- 3. All Pet(s) should be fully vaccinated against common infectious disease.
- 4. All pet(s) should remain on leash, not more than 1.5m in length, at all time.
- 5. For "Fighting dogs", or other "known dangerous dogs" as classified under the Dangerous Dogs Regulation (Cap 167D), muzzle is required and it should be on a leash not more than 1.5m in length.
- 6. Participants shall prevent their Pet(s) from making excessive noise at the event.
- 7. Participants shall keep the event space clean and hygienic at all times. Pet Owners shall immediately clean up any faeces or urine the Pet(s) have deposited and shall provide their own sealed bags, containers and/or tools for proper waste disposal.
- 8. Participants shall be solely responsible for any injuries to their Pet(s) and/or for any injuries and/or damage to and/or loss of property and/or belongings of others while at the event. Swire Properties Management Limited shall not be responsible and do not assume any liability for any such injuries, damage to and/or loss, whether such injuries, damage and/or loss is caused by Swire Properties Management Limited or otherwise.
- 9. If Participants are found to be in breach of any of these Terms and Conditions and/or if Swire Properties Management Limited in its sole discretion determines that the behavior of the Pet(s) is a threat to and/or a disturbance to others, Swire Properties Management Limited shall have the right to deny entry to or request Participants and their Pet(s) to leave from the event immediately.
 - a. vaccine status of the pet is not clear;
 - b. the pet is showing signs of illness;
 - c. the pet is showing aggression toward any pets or people;
 - d. the pets cannot be controlled by the owner or handler.
- 10. Participants should bring their own drinkable water and water bowl for their pets.
