

'above' 6th Anniversary Campaign
Terms & Conditions

1. The promotion period is from 1 September 2023 to 24 September 2023 (both dates inclusive) (the “**Promotion Period**”).
2. Only **above** members (excluding Pre-Member) are eligible to participate in the promotion.
3. Eligible sales receipt(s) and electronic payment receipt(s) issued by Participating Merchant(s) at Pacific Place Mall or Starstreet Precinct must be presented at Pacific Place Level L2 Concierge Desk, OR Level L3 Pavilion (**above Platinum** members only), OR Level L4 **above** Lounge (**above Black** members only) OR uploaded through Pacific Place Mobile App during the Promotion Period.
