## 2025 Pacific Place Christmas Workshops – Terms and Conditions

- 1. Workshop registrations will start on 14 November 2025 at 11am. Participants can only register online at <a href="https://christmas2025.pacificplace.com.hk/en/workshop">https://christmas2025.pacificplace.com.hk/en/workshop</a> via electronic payments. No walk-in is allowed.
- 2. Participants are required to join the Pacific Place Loyalty Programme **above** and present their member ID of the registered **above** account before attending the workshop.
- 3. Registrations are on a first-come, first-served basis. Participants can only register and attend **ONE** of the workshops during the promotion period. Duplicate registrations will not be accepted.
- 4. Tickets for the workshop are priced at HK\$450 per participant and include 1 workshop material pack. The workshop pack is available in different versions, selection is offered on a first-come, first-served basis and is subject to availability.
- 5. Each eligible **above** member may sign up for one guest ("Guest") during online registration for the same registered workshop session at an extra HK\$450 participation fee subject to quota availability. No walk-in guest will be allowed.
- 6. Each participating child (aged 12 or below) must be accompanied by an adult (aged 18 or above) during the entire activity. No seat and no material pack will be provided for the accompanying adult.
