



Starstreet Precinct 2019 Christmas Gift Redemption Programme - Terms and Conditions:

Same-day electronic receipt and credit card slip issued by eligible Starstreet Precinct tenants must be presented at the Gift Redemption Counter (located at the wooden deck on Wing Fung Street, outside Three Pacific) on the same day of purchase to redeem the Shopping Reward.
